## **ANA ANNOUNCES FORMAL RECOGNITION OF WOUND, OSTOMY AND CONTINENCE SPECIALTY NURSING PRACTICE**

**SILVER SPRING, MD** – The American Nurses Association (ANA), the largest nursing organization in the U.S., announces the formal recognition of wound, ostomy and continence (WOC) nursing as a specialty.

WOC nursing is an evidence-based practice designed to improve the quality of life for persons with select disorders of the gastrointestinal, genitourinary (reproductive and urinary), and integumentary (skin and associated structure) systems.

“ANA is pleased to recognize the specialty status of this essential area of nursing practice,” remarked ANA President Rebecca M. Patton, RN, MSN, CNOR. “ANA plays a vital leadership role in protecting the public by assuring quality in the clinical, administrative, education, and research domains of nursing practice. We set the bar high by establishing rigorous standards for the achievement of specialty status. Granting this specialty recognition underscores the importance of wound, ostomy, and continence nursing practice to patients, and the dedication of practitioners and professional organizations to assuring ongoing excellence and patient safety in this area of nursing practice. It is a very significant achievement.”

Kathleen Lawrence, RN, MSN, President-Elect of the Wound, Ostomy and Continence Nursing Society (WOCN) – which represents more than 4,200 health care professionals who are experts in the care of patients with wound, ostomy and incontinence – says the formal recognition is an important milestone for the specialty. "The Wound Ostomy and Continence Nurses Society believes that the ANA recognition of our specialty, scope and standards is invaluable. The ANA process guided the documentation of the profession's valuable history, our current achievements, and the depth and breadth of our professional practice. We know this will be an important document and a vital resource for our members."

During the late 1990s, the ANA convened representatives from various specialty nursing groups to address the need for consistency in standards of practice and to identify a formal mechanism to confirm professional recognition of specialty practice based on 14 designated criteria for specialty recognition. This resulted in the ANA, via its Congress on Nursing Practice and Economics, becoming the neutral reviewing body of specialty nursing scope of practice statements and standards of practice.

In recent years, several nursing specialties have completed the multi-level ANA review process and received formal recognition. They are: Plastic Surgery Nursing and Vascular Nursing in 2004; Nephrology Nursing in 2005; and Legal Nurse Consulting, HIV/AIDS Nursing, and Holistic Nursing in 2006.
