Dear Congresswomen Underwood and Kiggans,

On behalf of the 49 undersigned organizations representing the Nursing Community Coalition (NCC), we extend our appreciation to you both for introducing the *Ensuring Veterans Timely Access to Anesthesia Care Act* (H.R.2234). The NCC is a cross section of education, practice, research, and regulation within the nursing profession representing Registered Nurses (RNs), Advanced Practice Registered Nurses (APRNs), nurse leaders, boards of nursing, students, faculty, and researchers. Together, we support this comprehensive effort to ensure patients, specifically our nation's veterans, have access to the high-quality care provided by APRNs.

We recognize how vital removing barriers to practice and increasing access to the high-quality care from our nation's nurses and APRNs, including our Certified Registered Nurse Anesthetists (CRNAs), are for the patient and the entire health care system. H.R.2234 would remove unnecessary barriers to care within the Veterans Health Administration (VHA), increasing access to care, decreasing wait times, lowering costs, and maintaining the highest level of care for veterans. Independent groups, such as the Brookings Institution<sup>2</sup>, as well as multiple peer-reviewed studies published in the Journal of Medical Care<sup>3</sup>, Health Affairs<sup>4</sup>, and Health Services Research<sup>5</sup> have supported and shown the safety and quality of CRNA provided care.

This important legislation not only aligns the VHA with current Defense Health Agency policy that allows CRNAs to be autonomous providers of anesthesia in the Army, Navy, and Air Force, it

also follows recommendations from a Temple University report on CRNA practice within the VHA. As the brief states, "Removing restrictions and allowing more CRNAs to practice autonomously is documented to have no negative impact on patient outcomes, may potentially provide a cost-effective solution to physician shortages, and may increase access to care." The VA's Office of Inspector General reports citing three times as many facilities facing a shortage of physician anesthesiologists as CRNAs<sup>7</sup>, and given reports out of both the Hampton Roads VA Medical Center (VAMC)<sup>8</sup> and the Denver VAMC<sup>9</sup> that physician anesthesiologist shortages have restricted veterans' access to care.

As we continue to support the health care of our veterans throughout the country and reduce unnecessary barriers to care to ensure the efficient delivery of high-quality care, passing the *Ensuring Veterans Timely Access to Anesthesia Care Act* (H.R.2234) is essential. We appreciate your leadership in this effort as we work to address today's challenges and prepare for a healthier tomorrow.
