## ABOUT THE **PTAP SELF-STUDY(IES)**

#### SUPPORTING DOCUMENTATION

- Supporting documentation provides a context for understanding the Program and the practice setting(s) where the program is operationalized.
- The applicant must submit self-study(ies) following the PDF bookmarking guidelines in Chapter 3 of the ANCC 2024 PTAP Application Manual.
- Each narrative can have up to 2 pieces of supporting evidence (but not required).

#### NARRATIVES

- Applicants will write a separate narrative to address each program criterion. A narrative is a description and demonstration (example) of how the PTAP requirements are present and operationalized within the program.
- Only one narrative description is allowed per criterion. A minimum of one paragraph per narrative component (description and demonstration) is required.

#### **TEMPLATES**

The PTAP/APPFA Team has developed templates to help applicants complete the requirements for self-study. All templates can be found in the Applicant Resource Center. Access to the center is granted after eligibility is confirmed.

#### WRITING TO THE PTAP CRITERIA

A narrative description of how the program operationalizes each criterion is required for each of the five domains: Program Leadership, Program Goals and Outcomes Measures, Organizational Enculturation, Development and Design, and Practice-Based Learning.

Narratives provide an opportunity to tell how the program is adhering to the accreditation criteria and requires both a description ("describe") and demonstrate ("example") for each criterion.

#### HOW TO WRITE A **DESCRIPTION ("DESCRIBE")**

- The description should be a general overview of the structures, processes, or policy(ies) used by the applicant program to meet the criterion requirement.
- ▶ Tell the who, what, where, when, why, and how (as applicable).
  - Who is involved or responsible? When does it happen and how does it happen? Why do you do that?
  - What do you do, or expect to do, every time, with every cohort, in relation to this criterion?
  - There should be no names in the description. This is person agnostic, but role specific.
- Close your eyes and listen to a colleague read your description out loud.
  - Is this capturing the entire process asked about in the criterion?
  - Does your response answer the whole auestion?
  - Can an outsider understand your structures and processes?

In the end, your descriptions provide an instructional guide on how to run the program.

#### HOW TO WRITE A DEMONSTRATE ("EXAMPLE")

- Tell a story that substantiates the structures, processes or policy(ies) in the description. The demonstration should be specific.
- The demonstration should be specific and detailed, showcasing how the applicant program operationalized the process (description) in a real-life incident.
  - Examples **must** include details such as names, dates, practice setting(s).
  - Talk about real people and real events.
  - The example must have the persons name, credentials, and role. If applicable state the practice setting. Do not use initials.
  - Tell a story about someone who went through an experience that demonstrates the component of the criteria.
- Do not attach a document in place of a written example.
  - If using a document to show something that happened, expand on how it relates to the process described and the events surrounding how it was used.
  - Additional supporting evidence in the narratives must be limited to no more than 2 documents.

#### **Demonstrations should** bring the structure, processes, and policies to life!

#### **GENERAL TIPS FOR** WRITING THE PTAP AND AWD SELF-STUDY

- Pause and reflect on the intent of the PTAP standard.
  - Determine what the question is asking, and remember to answer all parts of the criterion requirement in each response.
- Answer the standard requirement directly and completely.
- When an individual's name is used in the narrative, indicate their position/ title to ensure the reader can follow your response.
- Give enough background/context for the reader to understand the response. You do not want the appraisers to assume anything.
  - Spell it out!
- Ask several colleagues to read your responses and tell you if you have answered the standard requirement.

### SELF-STUDY SUBMISSION CHECKLIST



#### SUPPORTING DOCUMENTATION

Each piece of requested supporting documentation is included and correctly bookmarked.

No more than two items of additional supporting evidence are allowed per criterion response.

#### NARRATIVES

Each criterion response has a description and demonstration narrative.

Descriptions are at least one paragraph and answer the question in the criterion completely.

Note: Complete but concise responses generally require 2-3 paragraphs per description and demonstration. Demonstrations tell a story that showcases how the process described is implemented in real life.

Note: Demonstrations must include names, roles, and credentials (if applicable) for any individual stakeholder or learner. Examples are written in the narrative format.

Note: Demonstrations referencing only an attachment are not accepted.

#### FORMATTING

All narratives and supporting documents are included in one single PDF file with bookmarks.

The PTAP Self-Study document file is no longer than 500 pages.

The PTAP Accreditation with Distinction (AWD) document file is no longer than 30 pages.

#### ABOUT THE LEARNER SURVEY

#### PURPOSE

The Learner Survey invites learners to share their perceptions of the applicant RN residency/fellowship program. Responses are a complement to the program's self-study and virtual visit.

#### **TYPES OF QUESTIONS**

- The learner survey asks questions relevant to the presence of essential elements of a practice transition program. It covers these topics:
  - Mentor(s)
  - Preceptor(s)
  - Resource allocation
  - Orientation process
  - Program curriculum
  - Program goals and outcome measures

#### **REQUIRED RESPONSE RATE**

The minimum response rate of 51% of all eligible learners to participate in the survey is required. Learners will have 30 calendar days to complete the survey once it has been distributed.

#### ELIGIBILITY

The survey invites learners who are currently in the program or who have participated in the program in the 12 months preceding the application submission date from all eligible sites(s) and practice setting(s).

#### CONFIDENTIALITY

Individual survey answers are completely confidential. Survey responses are submitted via a secure website, which only authorized PTAP/APPFA Team may access. No one in your program can view individual responses.

#### **REPORTING OF RESULTS**

Responses from your program are combined to produce a summary report that includes the average aggregate response for each domain about the RN residency/fellowship program. Demographics are not included in the summary.

Learners who *participated* in the RN residency/ fellowship program during the 12 months preceding the application are requested to respond to the Learner Survey.

- ► The The number of learners ("N") from eligible site(s) and practice setting(s) who participated in the program in the previous 12 months, including any still in the program, who completed or who left the program, must be reported on the PTAP Application Form, regardless of their current status with the organization.
- At least 51% of the N reported on the PTAP Application Form must complete the survey. Failure to meet this threshold will result in the application review process ceasing.
- ► The PTAP/APPFA Team will provide written confirmation of survey dates and additional distribution instructions to the Program Director. The survey hyperlink will be provided by the PTAP/APPFA Team.

## ABOUT THE VIRTUAL VISIT

#### PURPOSE

- ▶ The virtual visit consists of a video conference between the applicant and appraiser team.
- ▶ The purpose of the virtual visit is to clarify, verify, and amplify program adherence to PTAP criteria.
- PTAP Appraisers utilize the virtual visit to determine operational consistency of the program across all participating sites and practice settings.

#### VIRTUAL VISIT DATE

- PTAP appraisers will propose three dates for the applicant to choose from for the virtual visit. Typically, the virtual visit is scheduled between five and eight weeks after document submission.
- If proposed date and time options do not work for the program, the Program Director must inform the PTAP/APPFA Team immediately with significant rationale.

#### **CONFERENCE CALL/VIDEO** REQUIREMENTS

- The applicant organization will arrange and pay for the conference call. Web conferencing systems with video capability (e.g., Zoom, Teams, WebEx) are required.
- The Program Director should communicate instructions, including what to do if the appraiser team experiences technical difficulties or cannot access the conference line, as directed.

#### **AGENDA**

An agenda is sent 2 weeks prior to the virtual visit from the Appraiser Team Leader.

#### LENGTH OF VIRTUAL VISIT

- The visit can last between 3-4 hours.
- > Depending on the number of sites in a multi-site review, alterations may be required to call times/ length. The Program Director must be available to the Appraiser Team Leader for a planning call prior to the visit.

#### **ATTENDEES**

- Program Director: Required to participate for the full length of the virtual visit; The visit will not be held if the Program Director does not participate.
- Executive Leadership: Required for brief interview; CNO (at system level if multisite program) and/or CMO (as applicable).
- Directors/Managers of practice setting(s) Settings: Required.\*
- Preceptors/Faculty: Required.\*
- Practice setting(s): Required.\*
- ► Learners: Required.\*
- Practice Setting Coordinator or Site Clinical Coordinator (SCC): May be required to participate (as applicable).
- \* Appraisers will select individuals by name/role if mentioned in self-study OR identify practice setting(s) for applicant to select.

#### **RECORDING THE VIRTUAL VISIT**

- Recording of the visit is prohibited.
- Consultants or curriculum vendors are not allowed to attend the virtual visit.

#### ADDITIONAL EVIDENCE AFTER THE VIRTUAL VISIT

Additional evidence must be submitted within 72 hours if requested by appraisers. There are no additional fees required for additional evidence requests.

Note: The virtual visit is the final applicant portion of the appraisal review process. The accreditation decision is not made by appraisers, and the outcome of the appraisal review will not be discussed at the virtual visit.

## ABOUT PTAP REVIEW OUTCOMES

- ▶ The Commission on Accreditation of Practice Transition Programs (COA-PTP) conducts a thorough, evidence-based review of the final appraiser report, aggregate survey response, and AWD self-study (when applicable).
- ▶ Following review, the COA-PTP votes to determine the outcome of the appraisal review for RN Residency/Fellowship Programs.
- ▶ The PTAP/APPFA Team notifies the Program Director of the decision. The possible outcomes of the COA-PTP's vote include:

#### ACCREDITATION REVIEW CHECKLIST

The Practice Transition Accreditation Program (PTAP) checklist is intended to guide applicants through major achievements of accreditation application and review.

#### NOTE

- The pre-application phase can last varying amounts of time depending on preparation time required for a program to meet PTAP standards and eligibility requirements.
- The application and review phase generally lasts 10 months or less, with 4-months of selfstudy writing/cycle preparation and 6-months or less of the accreditation review.
- Applicants can expect an accreditation decision within 6 months of submitting their self-study documents.

#### **PRE-APPLICATION PHASE**

#### PREPARE

Start communicating with the PTAP/APPFA Team early. Prepare your team for your application:

- Review the **ANCC 2024 PTAP Application Manual**. Ensure your program meets eligibility.
- Complete the accompanying **<u>Gap Analysis Tool</u>**.
- Consider attending an **PTAP Introductory Workshop**.

#### APPLY

Choose one of our four annual **application cycles**; communicate your plan to the PTAP/APPFA Team. For questions about what is expected on the application form, contact us at **practicetransition@ana.org**.

- Download and begin to fill out the application form.
  - Finalize your application form and required application documents (e.g., organizational charts).
  - Set up your application email to send to the PTAP/APPFA Team.

tip Space in each cycle is limited; don't delay sending your application.

Send your completed application form and required documents to practicetransition@ana.org.

- Check the application open date on the website. The PTAP/APPFA Team accepts applications at 9:00 a.m. ET. The cycle will remain open until it fills or until the date indicated on the website.
  - **Programs receive a response within one week of application form submission.** The PTAP/APPFA Team may communicate during this time to ask for program clarifications. Official applicants are accepted into the review cycle via issuance of an eligibility letter.








Screenshot 4: Creating a new bookmark.




