COMPOSITION	Executive Officer (CEO). The CEO may delegate the Chief Operating Officer (COO) or Chief Nursing Officer (CNO) to serve in the CEO's stead.	
	c. Six (6) Constituent or State Nurses Association (C/SNA) or Individual Member Division (IMD) members recommended for appointment by the ANA Committee on Appointments (COA); the recommendations of the ANA COA are forwarded to the ANA Board of Directors for consideration

	a. The two (2) trustees appointed by the ANA President are appointed to serve a one-year term	
TERM OF OFFICE	b. The executive officer of the ANA (CEO, COO or CNO) serves a life-time term until the officer resigns their employment with ANA, is removed by the CEO, steps down as a trustee of the ANA-PAC, or the majority of the PAC-Board votes them from office.	
	c. The six (6) trustees recommended for appointment by the COA, who are approved by the ANA Board of Directors, are appointed to serve a two-year term	
TERM LIMIT	The two (2) trustees appointed by the ANA President are limited to four (4) consecutive one-year terms of service	



	b.	The remaining six (6) trustees are limited to two (2) consecutive two-year terms of service	
	C.	A trustee appointed to fill a vacancy who serves more than one-half (1/2) of the designated term of service shall be deemed to have served a full term	
	d.	The appointed ANA executive does not have a term limit	
TIME COMMITMENT	a.	Board meets via conference call four (4) times a year or more as needed, with additional duties handled via email	
	b.	Board meets in person as needed	
Nominees must:			
QUALIFICATIONS	a.	be active members of a C/SNA/ANA or IMD members and registered voters	
	b.	demonstrate interest in political activities, evidenced by involvement with the political action committee of a C/SNA-PAC and/or experience in political campaigns and/or political fundraising;	
	c.	have indicated their willingness to give or raise a minimum of \$1,000 per calendar year for the ANA-PAC	
	d.	proven relationship builder with both elected officials and ANA members	
	e.	have a pattern of consistent contributions to the ANA-PAC
