On behalf of the ANA Board of Directors, the Committee on Appointments issues this call for qualified nominees for appointment to seats on the:

**Committee on Bylaws**

- Three (3) seats open to ANA Members (C/SNA-ANA or IMD).
- Terms of Service: January 1, 2020 – December 31, 2021.
- Appointed members have a knowledge of and interest in ANA and/or C/SNA governance, parliamentary procedure and organizational management.
- State level experience with bylaws development is especially desired.

**Committee on Honorary Awards**

- One (1) seat open to ANA Members (C/SNA-ANA or IMD).
- Term of Service: January 1, 2020 – December 31, 2021.

**Committee on Honorary Awards Subcommittee**

- Twelve (12) seats open to ANA Members (C/SNA-ANA or IMD) appointed to a six-month term of service.
- Term of service: September, 2019 – March, 2020.
- Members must be available to:
  - Participate in orientation on September 25, 2019 from 12:00pm -1:00pm EDT.
  - Review award nominations between October 9 - 21, 2019; and
  - Participate in a call to discuss award nominations recommendation with the Chair of the Committee on Honorary Awards on October 25, 2019 between 1:00pm – 5:00pm EDT.

**Committee on Nursing Practice Standards**

- Two (2) seats open to ANA Members (C/SNA-ANA or IMD) with a term of service from January 1, 2020 – December 31, 2023.

- One (1) non-voting alternate seat open to ANA Members (C/SNA-ANA or IMD) with a term of service from January 1, 2020 – December 31, 2021.
- Diversity in practice, administration, education, and research experience is valued.

#### **Minority Fellowship Program (MFP) National Advisory Committee**

- Four (4) seats open to ANA Members (C/SNA-ANA or IMD) with a term of service of January 1, 2020 – December 31, 2022
- Candidates must be Ph.D. or DNP prepared with backgrounds in mental/behavioral health and/or substance abuse disorders and have an interest in leadership and mentoring minority nursing students.
- Individuals with experience in community-based/ population-specific clinical practice; state, local or federal policy-making; editorial/publishing; academics (specifically, experience working with minority nursing graduate students specializing in mental health and/or substance abuse) are especially desired.

#### **Professional Policy Committee<sup>1</sup>**

- Four (4) seats open to ANA Members (C/SNA-ANA or IMD).
- Terms of Service: January 1, 2020 – December 31, 2021.
- Nomination of individuals with prior experience attending/participating in the annual Membership Assembly meeting is encouraged. Clinicians are especially encouraged to apply.
- Ability to attend the annual Membership Assembly meeting is essential.
