

**2023 Nurses Month  
Amazon Gift Card Giveaway**

**Official Giveaway Rules**

1. **Introduction:** The American Nurses Association (“ANA”) is giving away 10 \$100 Amazon gift cards throughout the month of May 2023 to celebrate nurses for all they do (“Giveaway”).
2. **Eligibility:** In order to be eligible for the Giveaway, (1) must be a registered nurse (2) must be in or from the 50 United States and the District of Columbia.  
Entries originating from any other jurisdiction outside of the 50 states of the United States or the District of Columbia are not eligible. This Giveaway is governed exclusively by the laws of the United States. You are not authorized to participate in the Giveaway if you are not located within the 50 United States or the District of Columbia. Volunteers, agents, contractors, and employees and their relatives (defined as parents, partner, spouse, children, siblings, grandparents) of American Nurses Association and its subsidiaries are not eligible to participate in the Giveaway. All federal, state, and local rules and regulations apply.
3. **How to Enter:** Visit NursesMonth.org during the May 1 – 31, 2023 and complete the entry form. Entrants must complete and fill out the requested information and hit the submit button.
4. **Drawing and Notification:** Winners will be selected May 1, 2023 through June 1, 2023, in a random drawing from all eligible entries, by ANA, the decisions of which are final and binding in all matters relating to the Giveaway. Odds of winning depend on the number of eligible entries received. Potential winner will be announced via push notification in each participating booth and email within five (5) business days after the drawing date (“Notification”). The potential winner will have five (5) business days from receipt of Notification to claim their prize. Each entrant selected as a potential winner must comply with all terms and conditions set forth in these Official Rules, and winning is contingent upon fulfilling all such requirements. If prize or prize notification is returned as undeliverable, winner does not claim the prize within five (5) business days after receipt of Notification, rejects the prize, or in the event of noncompliance with these Official Rules and requirements, such prize will be forfeited, and an alternate winner will be selected from all remaining eligible entries. No compensation will be given for prize forfeiture.
5. **Prizes:** Throughout May 2023, entrants will have the opportunity to win one of 10 \$100 Amazon gift cards.
6. **Winner cannot win more than one prize.** No substitutions of prize by winner are permitted, but ANA reserves the right to substitute a prize of equal value due to prize unavailability. Prizes are not redeemable by winner for cash value. All taxes, fees, and surcharges on prizes are the sole responsibility of winner.
7. **Conditions:** By participating, entrants and winner(s) agree to release and hold harmless ANA, its subsidiaries, affiliates, advertising and promotions agencies, partners, representatives, agents, successors, assigns, employees, officers, directors, and volunteers from any and all liability for loss, harm, damage, injury, cost, or expense whatsoever including, without limitation, property damage, personal injury, and/or death that may occur in connection with, preparation for, travel to, or participation in Giveaway, or possession, acceptance, and/or use or misuse of prize or participation in any Giveaway-related activity, and for any claims based on publicity rights, defamation, invasion of privacy, and merchandize delivery. A potential winner may be requested to provide ANA with proof that the potential winner is the authorized account holder of the email address associated with the winning entry.
